**ORDER TOLLING LIMITATIONS  
ON TRUSTEE'S AVOIDING POWERS  
AND WAIVER OF  
DEBTOR'S RIGHT TO CONVERT**

1. Came this day the Debtor, by Counsel, \_\_\_\_\_ (“the Transferee”), and the Chapter 13 Trustee who have advised the Court that the Debtor filed this case on \_\_\_\_\_, 20\_\_\_\_; that the Debtor did in \_\_\_\_\_, 20\_\_\_\_, transfer to the Transferee certain real estate located in XXX County, Virginia, known as tax map parcel number \_\_\_\_\_ (“the property”); that this transfer was, pursuant to Code section 548(a)(1)(B), one for less than a reasonably equivalent value; that as a condition of confirmation of this case they have reached an agreement regarding this transfer; that this case is otherwise ready for confirmation; and that entry of an order embodying this agreement is important to preserve the rights of this or any subsequent Trustee in this case to proceed against the above-described transfer of real estate.

2. Accordingly, for cause shown, and it otherwise appearing proper to do so, it is hereby **ORDERED** that:

A. Pursuant to Code section 105, the time limitation set forth in Code section 546(a) which limits the time period during which this Trustee, or any subsequent Trustee in this case, may bring an action against the Debtor, the Transferee, or any subsequent transferee of the above-described property to recover said property under

Code sections 544, 545, 547, 548, or 553 is hereby tolled, and shall not begin to run, until such time as (i) the Trustee has distributed to the Debtor's priority and unsecured creditors a net total of \$ \_\_\_\_\_, which is the amount required to meet the "Chapter 7 test" [Code section 1325(a)(4)] in this case, or (ii) this case is converted to a bankruptcy case under a different Chapter, whichever event occurs first.

B. The Clerk shall cause a copy of this Order to be forwarded to the Debtor, Debtor's counsel, the Transferee, and the Chapter 13 Trustee.
